Contribution to Development Objective

Development Objective

The proposed Project Development Objective is to strengthen the Recipient's capacity for the implementation of its cadastre at a national level; and to increase the number of land rights registered in selected areas.

Contribution of the requested Grant to the Development Objective?

The objective of the proposed grant is to strengthen the existing Spatial Data Infrastructure (SDI) through technical assistance and additional expertise. The grant activities will contribute to the Development Objective of the parent project in two complementary ways:

- 1) Building capacity in geographic information management will help increase the quality of the geodata that will be used to support land registration activities and inform on existing land use and restrictions. Increasing the quality of the existing datasets by standardizing them is a necessary precondition to accurately overlay different layers of geographic information.
- 2) Supporting the Government of Senegal in the development and implementation of their National Spatial Data Infrastructure will contribute to enhance the use, the value and the impact of the land data that will be disseminated on the National Spatial Data Infrastructure platform. This will also help sustain a demand from government agencies, private actors and the population to maintain and update the land data that will be collected during the project.

Summary

Summary description of Grant Financed Activities

The grant will contribute to the proposed objectives through three activities:

- (i) Assessment of the National Spatial Data Infrastructure and the national strategy for its development using the Integrated Geospatial Information Framework (US\$ 60'000). The assessment report produced will help inform the activities aimed at upgrading the existing platform in Component 1 of the project as well as activities financed by this grant.
- (ii) Building capacity in geographic data management through training in data standardization and a Knowledge Exchange on Spatial Data Infrastructure management with South Korean officials (US\$ 300'000). 75 producers of geographic information, IT specialists and NSDI managers will be trained. This activity will support the systematic land registration activities under Component 2 of the project. This activity will benefit from the expertise of several potential South Korean partners, such as NGII and LX.
- (iii) Awareness raising and communication with government agencies, elected representatives, territorial authorities and CSOs on the potential of geographic information and the existing platform to help them achieve their mission (US\$ 140'000). This activity is expected to reach 600 people through a national workshop for the dissemination of the assessment report as well as regional workshops aimed at promoting the National Spatial Data Infrastructure among regional stakeholders to encourage their participation in the production and use of geospatial data. The recommendations of the assessment report will help inform the strategy for conducting awareness raising and communication activities.

It is expected that the program will lead to improved efficiency and autonomy of government agencies and territorial authorities in managing their geographic information. In addition, increased availability of good quality data for the creation of services and innovation based on geographic information is expected to increase competitiveness.

The activities will acknowledge KGGTF support both on the assessment report produced and during capacity building and awareness raising activities.
